The entire unit and a selection of bits fit into a wheeled case that weighs under 50 pounds. The Core EZ drills holes from 3 into 10 in with ease. The entire unit is mounted on a central guide shaft rigidly anchored to the wall that supports the weight of the tool during the drilling process. Having the system's anchor in the middle of the hole eliminates damage to the wall.



4.0 SAFETY INSTRUCTIONS

4.1 KNOW THE RULES & YOUR EQUIPMENT.

Most job sites have rules governing equipment use & maintenance. Before starting at a new work location, check with the supervisor or safety coordinator. Ask about any rules or regulations you need to abide.

4.2 RECEIVE PROPER TRAINING.

Do not operate this machine unless you have received operational and maintenance training from a U.S.SAWS representative or from an authorized distributor for U.S.SAWS.

4.3 PROTECT YOUR FEET.

Observe all applicable local, state and federal safety regulations. Wear OSHA approved foot protection.

4.4 PROTECT YOUR EYES.

Observe all applicable local, state and federal safety regulations. Wear OSHA approved safety glasses.

4.5 PROTECT YOUR HEARING.

Observe all applicable local, state and federal safety regulations. Wear OSHA approved hearing protection.

4.6 DRESS PROPERLY.

Do not wear loose clothing or jewelry that can be caught in moving parts. Wear protective hair covering to contain long hair. Keep hair away from motor air vent. Rubber gloves and non-skid footwear are recommended when working outdoors.

4.7 AVOID A DANGEROUS ENVIRONMENT.

Do not expose machine to rain. Do not use machine in wet conditions. Water entering a power tool will increase the risk of electric shock. Keep work area well lit. When working at an elevated location, pay attention to articles and persons below. If operating the power tool in damp locations is unavoidable, use a Ground Fault Circuit Interrupter (GFCI) protected supply. Use of an GFCI reduce the risk of electric shock.

4.8 AVOID ANY AREAS OR ACTIONS THAT EXPOSE YOU TO CARBON MONOXIDE.

4.10 KEEP CHILDREN AND VISITORS AWAY.

Do not allow anyone to stand in line with the blade path. Do not let children or visitors contact machine or extension cord. Keep children and visitors away from the work area.

4.11 KEEP FIRM GRIP ON MACHINE.

During normal operation as instructed in Section 6.0, keep a firm hold on the handle grips and maintain control of the machine until the blade completely stops.

4.12 SHUT OFF MACHINE.

When not in use, before servicing and when changing accessories shut off engine. Release the lever switch and move the on/off switch to the OFF position. Move the fuel valve lever to the OFF position.

4.13 STORE IDLE EQUIPMENT.

The machine and tools should be stored in a dry and secure location when not in use. Keep equipment out of reach of children.

4.14 DO NOT OVERREACH.

Keep proper footing and balance at all times.

4.15 OBTAIN SAFETY DATA SHEET (SDS) FOR ALL WORK SURFACE MATERIALS.

This includes primers, all coatings, adhesives, tile and crack filling materials, etc. Do not attempt to cut, clean out or remove material without SDS information. Consult SDS sheet for hazards information. Be aware that some materials are explosive as a dust.

4.16 MAINTAIN MACHINE WITH CARE.

Keep machine clean and follow maintenance procedures for better and safer performance. Keep handles dry, clean, and free from oil and grease. Follow instructions for lubricating and changing accessories.

4.17 REMOVE ADJUSTING TOOLS.

Form a habit of checking to see that tools such as adjusting wrenches are removed from the machine and properly stored before starting the engine.

4.18 STAY ALERT.

Watch what you are doing. Use common sense. Do not operate machine when you are tired or fatigued.

4.19 DO NOT USE DRUGS, ALCOHOL, MEDICATION.

Do not operate machine while under the influence of drugs, alcohol, or any medication.

4.20 KEEP THE RIGHT PARTS IN THE RIGHT POSITIONS.

Do not operate machine with parts missing or improperly mounted.

4.21 CHECK DAMAGED PARTS.

Verify all machine guards are in good condition and will function properly before using the machine. Check for alignment of moving parts, binding of moving parts, breakage of parts, mounting, and any other conditions that may affect machine operation. A guard, power switch or other part that is damaged should be properly repaired or replaced by an authorized service center unless indicated elsewhere in this instruction manual. Do not operate machine if lever or engine on/off switch does not function properly.

4.22 SECURELY MOUNT ACCESSORIES TO THE MACHINE.

Extra care must be taken an elevated location to prevent injury to someone on a lower level in the event the tool or accessory should drop. Do not operate without fall protection for operator and debris protection for public.

4.23 NEVER TOUCH THE MOVING PARTS.

Never touch moving parts such as shaft and drill extensions.

4.24 STOP OPERATION IMMEDIATELY IF ANY ABNORMALITY IS DETECTED.

Use proper heavy lifting procedures. Read & understand manuals before loading & unloading.







5.3 **Assembly**

5.4 Mount hex core bit adapter to required size core bit.



Install grinder onto gearbox. Ensure that the pin is fully rotated into the locked position.



5.6 Secure a water supply (i.e; water tank, water truck, garden hose) -MAX 25PSI.


AWARNING

WARNING: Always insure that the switch is in the "OFF" position before plugging the unit into electrical power.



CAUTION: Never leave the drill running unattended. Turn power off when not in use.

6.1 Mark center of core.



6.2 Drill anchor hole with 3/8" masonry bit a minimum of 5" deep, unless using toggle anchors.



6.3 Set anchor pin.



6.4 Remove nuts from anchor bolt.



6.5 Mount guide post.



6.6 Adjust anchor point.



▲ CAUTION

CAUTION: Once the guide post is tight, push and pull on it several times by hand to stretch and seat the anchor into its tightest position, then, re-tighten the guide post. Repeat this complete procedure three times to ensure that the guide post is securely centered.

6.7 Final tightening procedure should be performed with the supplied 1-1/2" wrench. In some cases the wrench should be lightly hammered to insure tightness.




6.8 Be sure guide post is clean & lubricated before sliding core bit assembly into place on the guide post.



6.9 Slide gearbox and grinder over guide post, ensuring to engage the locking pin on hex drive.



6.10 To mount water feed tube, slide it over the guide post and thread the feed nut while aligning the mounting plate bolts on the back of the gearbox.



AWARNING

WARNING: Over watering can force water into the gear box. If water is seen flowing through relief port reduce water pressure.

6.11 Turn on water. Minimize water usage, do not flood the cut with water. Typical water consumption should be under 1 gallon per minute (max 25 psi).



Hold down grinder trigger and turn advancing nut with a 3/4" wrench to core hole.







Vertical Drilling Floors



- Remove the entire machine out of the drilling location (ex. cored hole) and place in a secure location for disassembly.
- Reverse feed nut, counterclockwise, to remove core bit and guide post.
- To remove core & anchor from guide post, strap chain wrench to core and apply opposite pressure with the 1

Horizontal Drilling Walls



- Unthread feed tube to remove the coring unit and leave the core and guide post in the hole.
- Re-stretch the anchor hole by pushing firmly on the guide post (similar to original tightening procedure).
- Unthread guide post.
- Remove core from hole.

6.10 **DISASSEMBLY STEPS**

6.10.1 STEP 1

Stop motor, unplug unit from power, and turn off water.

6.10.2 STEP 2

Remove the core.

Based on job site conditions there are several ways to remove the core. See full instructions to the left.


6.11.1 **HOW TO REMOVE A JAMMED CORE BIT**







WARRANTY AND SERVICE

9.0 WARRANTY AND SERVICE

9.1.1 Warranty

This document is to be used as a guide in determining warranty policies and procedures for U.S.SAWS and its U.S.SAWS products. It is to be used in determining whether a warranty is justified and as a procedural guide in completing a U.S.SAWS warranty claim form.

9.1.2 Warranty Responsibility

The distributor or the end user must prepare a Machine Warranty Information Card when the machine is delivered. Failure to comply will make any and all warranties on this equipment null and void. Credit for warranty repairs will be given only after receipt of the WARRANTY CLAIM FORM, properly completed with all the required details. Submittal details are described later in this document.

9.1.3 Warranty Policy

- **9.1.3.1** U.S.SAWS warrants its U.S.SAWS products against defects in material and workmanship under normal and proper use for a period of one year (365) days from the date of delivery; in the case of Rental Fleet Machines, date of assignment to Rental Fleet. Such warranty is extended only to the buyer who purchases the equipment directly from U.S.SAWS or its authorized distributor. This warranty does not include expendable parts such as, but not limited to, plugs, cutters, blades, blast wheel, wear parts, liners and seals.
- **9.1.3.2** The obligation under this warranty is strictly limited to the replacement or repair, at US SAWS's option, of machines and does not include the cost of transportation, loss of operating time, or normal maintenance services.
- **9.1.3.3** This warranty does not apply to failure occurring as a result of abuse, misuse, negligence, corrosion, erosion, normal wear and tear, alterations or modifications made to the machine without express written consent of U.S.SAWS.
- **9.1.3.4** Warranty request must be submitted in writing within thirty (30) days after failure.
- 9.1.3.5 Written authorization to return merchandise under warranty must first be obtained from U.S.SAWS.
- **9.1.3.6** U.S.SAWS reserves the right to inspect and make the final decision on any merchandise returned under warranty.
- **9.1.3.7** U.S.SAWS offers no warranty with respect to accessories, including but not limited to, engines, motors, batteries, electrical boards, tires and any other parts not manufactured by us but which the original manufacturer warrants.
